# PROJECT SPOTLIGHT: Herbert Hoover Dike Culvert Replacements

Project: Replacement of Culverts FC-1 & HP-7 at Herbert Hoover Dike in Glades County

After a long submittal process, work began at FC-1 with our earthwork subcontractor Messier Land Developing in early August. Their work consisted of first removing 500LF of the existing dike along with over 700 cubic yards of slope protection on the old dike. Once the area was sloped back and leveled out from its original elevation of 39.0' to elevation 18.0', Johnson-Davis crews, under the watchful eye of Superintendent Leonard Dennis, mobilized to install 380 wall-feet of steel sheet pile at FC-1 and 320 wall-feet at HP-7.

The existing headwalls were 30" thick and stood over 16' tall and a span of 65LF. The newly acquired Maverick Demolition Hammer was utilized to break up the headwalls. Once all of the concrete and existing culverts

were removed from the work area, Messier readied the area for our dewater-

ing system. The silty clay soil required our crews to install wick well-points to achieve the required dry conditions. After extensive pumping to establish a dry subgrade, Mosley & Son started construction of the concrete endwalls.

The footers were formed and poured. Each of the two footers required in excess of 175 cubic yards of concrete. Once the footers were poured and the forms

were removed, the Johnson-Davis crews were ready to start the tedious task of installing double 108" pipe culverts which required stone and sand backfill for the outer 50' segments and excavatable flowable fill for the middle 50' segment of the 150' run.

The middle section requiring the flowable fill was constructed in two phases. The first phase consisted of setting four 4,000 pound anchors on either side of the two culverts and then pouring the flow-

able fill to the pipe invert elevation of 9.5. After the flowable fill had been set up, the pipes were positioned and strapped down to the anchors to prevent the pipes from "floating" while the remaining flowable fill was pumped around the pipes to the required specifications.

The remaining work at FC-1 includes setting two control gates, installation of 1000 tons of granite

rip-rap, and the replacement of the levee to preconstruction condition. Work at the HP-7 structure is very similar except the replacement pipe diameter is 60".

Work at both locations is expected to be completed by the end of January 2011. This tight construction schedule will challenge our forces to deliver on time and on budget.

# Project Spotlight: Kissimmee Lakefront

In 2006 when approached by one of our best customers to bid work in Kissimmee, our answer to Burkhardt Construction Inc. was "It's a little too far". In 2007, when given a second opportunity, our answer was "Where are the plans?", and "When do we start?"

The Kissimmee Lakefront Phase I project is our third contract for Burkhardt Construction Inc. in the city of Kissimmee and by far the most difficult. Every excavator bucket unearths new challenges to our entire construction and management team.

We broke ground in early January 2010 with Superintendent Glenn Pultz stretching his geographic sphere of influence. He dealt with

the numerous conflicts and problems typical of the infrastructures of towns and small

cities constructed prior to the modern utility standards utilized during the mid 1970s.

The project involved the relocation of all municipal utilities and storm water management facilities from Lakeshore Drive to adjacent streets allowing for the development of a scenic waterfront park and pedestrian-friendly recreation area.

# PROJECT SPOTLIGHT: I-595

I-595 is Broward County's major east-west thoroughfare used by residents and visitors to get to work, shops, entertainment venues, the airport, Port Everglades and the beaches.

More than 180,000 vehicles per day use 595, and by 2034 that number is projected to swell to beyond 300,000 vehicles per day.

On March 3, 2009, the FDOT signed a public-private partnership (P3) agreement with I-595 Express, LLC to serve as the concessionaire to design, build, finance, operate, and maintain the 595 corridor improvements project for a long-term commitment of 35 years.

The improvements to the 595 corridor will vastly improve driving conditions along 595 and preserve the future vitality of the corridor. The project limits extend from the I-75 / Sawgrass Expressway interchange to the I-595 / I-95 interchange in Central Broward County.

Improving mobility along the 595 corridor is not just a necessity for residents and visitors; it will have a significant impact on South Florida's economy. 595 is vital to the shipment of freight and goods around South Florida.

Roadway construction began in *Segment C* on February 26, 2010, in the vicinity of

Pine Island Road. As part of the Bergeron Land Development Inc.

"595 Team", Johnson-Davis is contracted to install storm drainage and fire suppression systems.

Our FDOT construction experience, professionalism, and manpower resources assist JDI being an integral part of this team as we continue to work both east and west at Pine Island Road within *Segment C*. Currently between four and five crews are constructing storm drain

along eastbound and westbound SR 84 and fire suppression main and drainage in the express lanes of 595.

Foreman Tony Ingraham and crew were the first to be introduced to the new world



of 595. As one of the largest contracted projects in the state of Florida, it is a project like no other.

The coordination and scheduling is monitored to the n-th degree for all crews, materials, and deliveries, and tracked through paperwork and new FDOT programs. Since September, crews including those of Chescal Ceance, Dave Fayssoux, and Odilon Hernandez, as well as many of the support crews....

..... have been contributing to the installation of drainage and fire suppression lines in Zones 4, 5 and 6 of *Segment C*. By the end of 2010, we anticipate the mobilization of a fifth mainline crew and a possible subcontractor if additional work areas become available. Superintendent Kerry Jackson's "hands on" approach and knowledge of this project has contributed greatly to make it more manageable.

Some of the challenges have been

the installation of parallel trunkline drainage along the westbound SR 84 steel sheet pile bulkhead. The adjacent controlled water of the New River Canal infiltrating the bulkhead has severely impacted production. Also, the tight working conditions, access to work zones, and coordination with other subcontractors have proved to be a juggling act. Our crews have done well making it work for all concerned parties.

As part of the "On the Job Training" (OJT) program, we are pleased to have met our goals with five

trainees. This is quite a task for many contractors, and our hats go off to the employees taking part and those training our employees.

Significant progress has been made on the design, field survey, geotechnical investigation, and utility coordination and relocation activities within all construction segments. By the end of 2010, most of the 10.5 mile project corridor along 595 and a portion of the 2.5 miles along Florida's Turnpike from Peters Road to Griffin Road will be under construction.

## Safety Musings

The holiday season passes, but the driving season never stops. Wishing all a safe and healthy new year...

When you drive, are you aware of what's going on all around you? Do you anticipate what drivers around you may do?

You are probably a good driver, but have you ever:

- Run a red light or stop sign?
- Jammed on your brakes to avoid a car?
- Had a near miss?
- Almost sideswiped a car?

These happen more often than most of us would care to admit. Accident-free driving is not simply luck or skill. It depends largely on the decisions we make and the actions we take based on those decisions.

Here are some suggestions to help prevent some of these situations:

- Don't talk on your cell phone, text, or read an email while driving.
- Look further ahead down the road, where you will be in a few seconds, rather than just right in front of your vehicle.
- Scan all around your vehicle to identify developing situations



including construction zones, pedestrians, and congested intersections. Check your mirrors every five to ten seconds.


- Use signals such as your horn and turn signals to communicate to other drivers your intentions. This allows them the opportunity to adjust their own driving.
- Think ahead, and have an escape route in mind so you can react quickly if something unexpected happens. This means no tailgating!
- Follow the two second rule. Watch the vehicle in front of you pass a fixed point such as a road sign, and then count the seconds it takes you to reach that same point. It should be at least two seconds.

# Rescued Ducklings: Helping Protect Our Environment

## Wellness: Diabetes Care

- Being overweight
- Not being physically active
- Cardiovascular disease



- Family background of Alaska Native, American Indian, African American, Hispanic/Latino, Asian American, or Pacific Islander
- A woman who had gestational diabetes while pregnant

To help prevent or delay diabetes, doctors recommend two things that we have all heard so many times: DIET and EXERCISE. But it is true! Research shows that even a little bit of weight loss makes a difference. Reducing fat, sugar, and sodium intake while increasing fruit and vegetable intake also helps.

Being overweight is a leading factor for type 2 diabetes as it can cause high blood pressure. It also prevents the body from correctly making and using insulin.

Some people have diabetes and do not even realize it. Others do experience warning signs and develop symptoms. If you have the following symptoms, you may want to speak with your doctor about getting tested and treated as it can help prevent or minimize damage:

- Increased hunger or thirst
- Blurred vision
- Sores that are not healing
- Increased urination, particularly at night

People who have been diagnosed with pre-diabetes, blood glucose levels higher than normal but not yet diabetic, can prevent the progression into diabetes following these steps as well. So, get moving now, and follow up with your doctor!

## OPEN ENROLLMENT

This is our annual open enrollment period. This means that this is the time to enroll in plans, make changes to benefits plans, and add or drop dependents. All changes will be effective January 1, 2011, for calendar year 2011. Your next chance to make changes will be in December 2011 to be effective January 1, 2012.

## WELLNESS BENEFITS

Our medical plans are being enhanced to include increased wellness benefits effective January 1. Medical wellness benefits following preventive care guidelines are now available at no cost to



at no cost to

employees or their dependents.

## BLUE CROSS/CERIDIAN INDEPENDENT AUDIT

With medical costs escalating, insurance carriers including Blue Cross have been conducting audits on groups in an effort to ensure all incurred costs are for dependents who truly belong on the group plans. Johnson-Davis has recently been selected for an audit.

If you have dependents on our medical plan, please be sure to respond when Ceridian contacts you requesting proof of dependent eligibility. They will be requiring documentation that family members who you have enrolled on our medical plan are in fact eligible to be on the plan. It is critical that you respond timely, or your dependents may be dropped.

Please note that this audit has been initiated by Blue Cross, and Johnson-Davis does not have control over this audit. However, please contact Human Resources if you need assistance complying with the request for information.

## SEEKING ALTERNATE COVERAGE?

If you would like assistance finding other coverage for a dependent or a loved one who may not be eligible to be on our plan, assistance is available. Contact our benefits insurance agency, Jordan Dynamics, at 800-832-1018.

Assistance is also available comparing plans such as helping compare the Johnson-Davis plan to the one where your spouse works. Contact Jordan Dynamics or Human Resources for guidance.

A main reason that people who have tried to quit have failed is because they have not had a plan. Prior to quitting, [smokefree.gov](http://smokefree.gov) states you

must "START":

- S: Set a quit date
  - T: Tell family, friends, and coworkers that you plan to quit
  - A: Anticipate and plan for the challenges you will face while quitting
  - R: Remove cigarettes and other tobacco products from your home, car, and work
  - T: Talk to your doctor about getting help to quit

## AFLAC


