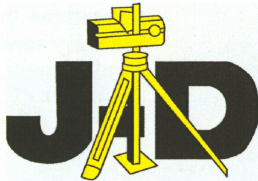

# PROJECT SPOTLIGHT: BETHESDA WEST

Shovels entered the ground at the N.E. corner of Boynton Beach Boulevard and US-441 on Tuesday, May 25, 2010, as Bethesda Healthcare System marked the official groundbreaking of the new Bethesda West Hospital. Five hundred county and civic leaders attended the historic event for this \$130 million, world class, not-for-profit facility. The new Bethesda Hospital will be an 80 bed, all private room, community hospital that provides comprehensive inpatient and outpatient medical services with state-of-the-art facilities.

Construction for Bethesda West Hospital officially began June 1, 2010. The project is expected to take 30 months to complete. The Johnson-Davis scope consists of installing sanitary sewer, water main, and drainage for the new hospital as well as some substantial off-site work. The off-site work consists of installing a 16 inch D.I.P. water main with two aerial crossings and also installing a 16 inch P.V.C. force main that included a Jack and Bore under Boynton Beach Boulevard.

The project is also an ODP (Owner Direct Purchase) project meaning that the owner (Bethesda) is actually purchasing all of the materials through Johnson-Davis. The ODP process has been a challenge for Project Man-

ager Pete Oja, who has had to work diligently with Bethesda and our vendors to ensure the purchasing process went smoothly.

Foreman Norm Weaver and crew have been on the job since day one and have made tremendous progress. The versatile crew has per-

formed several different tasks in several different areas within the site including installing on-site drainage and completing the off-site water and off-site force mains. The off-site force main work included a Jack and Bore across Boynton Beach Boulevard

that was performed by Wakefield Road Boring and assisted by Johnson-Davis. The sanitary sewer posed an enormous challenge for Norm Weaver and crew due to extremely deep excavations ranging from 12 feet to 16 feet in depth and also included wide-ranging dewatering methods needed to

unsaturate the area.

Johnson-Davis received assistance from several specialty contractors to complete the project including Drawdy Construction, Murray Logan, Wakefield Road Boring, Hardrives, and D.S. Eakins. Drawdy Construction drove the piles and poured the pile cap for our water main aerial crossings, and Murray Logan installed the sanitary sewer lift station. Wakefield Road Boring bored 30 inch casing pipe under Boynton Beach Boulevard for installation of 16 inch force main carrier pipe. Hardrives restored

the asphalt pavement that was disturbed during the off-site portion of the project, and D.S. Eakins installed portions of the mainline drainage to ensure that Johnson-Davis kept on schedule and met all established deadlines.

The crew has recently completed the sanitary sewer and is now moving to complete the on-site drainage in the coming weeks. Work is estimated to be complete by the end of August 2011. Johnson-Davis looks forward to the comple-

tion of the underground work that will help in serving the growing needs of western Palm Beach County.

### Safety Musings: Electricity

Electricity is nature's most versatile form of energy. The hazard of electricity cannot be eliminated, but it can be controlled through education, work practices, and engineering. The more we understand about electrical energy, the safer we will be at work and home.

The 2009 Bureau of Labor Statistics' Census of Fatal Occupational Injuries reported 168 fatalities from contact with electrical current. While that number is down from the prior year of 192 fatalities, it would still be too many if even one was at one of our work sites. Contact with overhead power lines accounted for 62 of the 168 fatalities in 2009 and 102 of the 192 fatalities in 2008.

Improperly using electrical equipment can create very



serious hazards for workers. Special safety features built into equipment often are rendered ineffective when equipment is manipulated. This can harm workers and damage equipment.

Always be aware of overhead as well as underground utilities, especially electrical lines. Never assume that an electrical line is dead! Have confirmation. Locates are a must 48 hours prior to project start up.

You can get an electric shock if you touch a grounded surface and energized electrical equipment at the same time. The shock happens when the flow of electric current (amperage) from the electrical equipment goes through your body to the ground. The seriousness of the injury depends on the amount and what part of your body receives the current. It also depends on how long the electric current flows. A small amount of amperage can hurt or even be fatal. Let's all be careful!



### SAFETY SCOOP

Johnson-Davis Inc. recently received the 2010 award of excellence for vehicle safety from the Safety Council of Palm Beach County. Our drivers approached two million miles driven without a chargeable collision incident. Kudos to all of our drivers!

Our OSHA incident rate for 2009 was 1.83 compared to 3.13 for 2010. We continue to be well below the national average. This reflects our average manhours of approximately 400,000.

Johnson-Davis continues to be one of the four contractors from the Florida East Coast AGC Chapter that is a member of the OSHA-CHASE Program. Congratulations to all!

## DAN FOLLETT 25 YEARS OF SERVICE



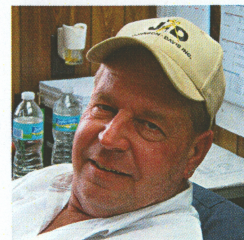

### **MIRBEC ERNEVIL** **15 YEARS OF SERVICE**



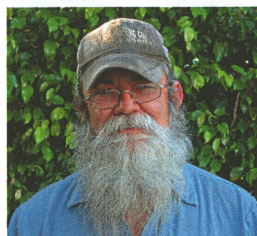

Because you provide all of this information, the tool can then give you very personalized information. You will receive a score as well as information as to how likely you are to develop certain health conditions.

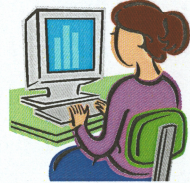
### What is in the report?
