




### THOMAS JACKSON 30 YEARS OF SERVICE

## Project Spotlight: 800 I Indian River Drive

St. Lucie County contracted Johnson-Davis to repair a 150 foot long, 20 foot tall failed slope at the west bank of the Indian River at 800 I South Indian River Drive. The work included clearing the slope of vegetation and injecting grout into the slope to seal voids that were believed to extend 20 feet into the slope and under the roadway. The voids could eventually cause failure to the highly travelled scenic roadway.

A series of 3000 psi 120 foot long concrete retaining segments was formed and poured to contain the grout as we moved from the shoreline vertically up to the top of the slope. This was to protect the steep slope from tidal and storm damage.

tion along the newly restored slope.

Our notice to proceed date was established for January 25<sup>th</sup> when Johnson-Davis mobilized and began clearing the slope. It was determined that ap-

proximately three times more slope required repair than originally expected, and this was to be completed without any delay to the reopening of the road.

Due to the narrow two lane road, the project allowed for a six mile closure of Indian River Drive. The road closure permitted our crews to safely transport materials to and from the project and keep

traveling residents and the public safe. We utilized a long reach excavator to reach the toe of slope which was 20 feet


down. It was used to grade the slope and place bank and shore rip rap.

The existing conditions of the

slope required custom wood-forming to accommodate large boulders that were to be left in place. Jaime Camargo and Everton Henry Sr provided expertise, and Tom Linsley and his crew began to form each 3000



The project also called for helical piles, chemical grouting, bank and shore rip rap, reinforcement mat, and new vegeta-

psi cap one at a time and pour flowable fill behind the carpentry work.

Creative approaches, such as adjusting construction sequences and utilizing precast concrete segments, were taken to ensure construction remained on schedule. Several changes had to be made to accommodate existing conditions and plan additions requested by our client. Johnson-Davis promptly addressed changes and

satisfied the needs of the project.

Adaptability and customer service are two phrases that legitimately describe this project. From the field to the office, J-D employees presented professionally and constructed another project with confidence.

The asbuilt drawings provided the County with valuable information to utilize these techniques in future slope restoration pro-

jects on the banks of Indian River.

This project is proof that with dedication, motivation, flexibility, customer service, and teamwork, the success of any challenging project is possible.

## Safety Scoop: Don't Keep It To Yourself!

The most rewarding part of being an instructor is seeing what you have taught in class make it into practice out in the field. So often we get into the groove of “doing business” and seem to think that we do training because we have to or because the law says we must. While that may be true, there are very good intentions behind the laws that mandate safety training.

If we only provided training because we had to, it would be a poor indicator of our company's current culture. When we provide training, it is done to empower those people in each training class with not only what the law expects, but also how we as J-D employees can meet these minimum requirements.

You've likely often heard that “knowledge is power” or “you've been given the tools to succeed” during or after a training class.

These statements are completely accurate in more ways than one. Not only do you learn valuable information meant to give you the ability to work safely, but you also

get the power to act on what you learned— as well as the power to fail to act.

The choice rests with each of you. There is a simple leadership exercise that is time tested and proven. A method that leaders use to drive their training home is called “Stewardship”. In this simple method, an instructor presents what he or she wants the student to learn, ensures that the student understands the lesson, and then releases the student back into their job site environment to practice what was learned. While practicing the instructor's teachings, the student will face challenges and stumbling blocks to overcome and should eventually reach their goals... having learned more and more along the way, but still ACCOMPLISHING those goals. One of the most important goals that a student MUST achieve is to teach what they have learned to others.

The instructor revisits the student often, acting as a coach or guide to the student in helping them to realize their goals. When the goal is reached, invaluable experience and

praise for following the right path are their own rewards. The next reward is in seeing other crew members practice what the student has now taught them as well.

When a student consistently fails to learn the lessons of the instructor, put into practice what they have been taught, or refuses the guidance of the instructor or mentor, then that student has allowed him/herself to become more of a liability than an asset and a danger to others they have in their charge. Firm limits must be placed on that student's responsibilities and not exceeded.

Whatever your role, look for opportunities to be both a teacher and a student, realize that there is *always* something more you can learn, and that there is *always* someone out there who can teach you something more than what you knew before you met them.

Arguably, the most important thing that anyone could ever learn is not to keep what you've learned to yourself. Use it by teaching it and practicing it!
