Project Spotlight: Pennock Industrial Park and Bush Road Drainage Improvements

The Town of Jupiter initiated a critical storm drainage improvement project aimed at enhancing flood control and improving public infrastructure. This project is to address stormwater challenges in key industrial and commercial zones that have historically been susceptible to flooding. Jupiter identified drainage systems in need of modernization to ensure effective water flow and reduce flooding during peak storm events.

Storm drainage upgrades are in progress in Pennock Industrial Park to strengthen infrastructure in the flood prone areas. Key improvements include new fire hydrants and valves on the water main, the rehabilitation of a 60" exfiltration trench, installation of a new exfiltration trench around the area, and Cured-In-Place (CIPP) lining of existing drainage. These upgrades will help increase system efficiency, extend the life of older pipes, and meet better performance standards. The work is being completed in phases to ensure minimal disruption to operations in the area, with strong coordination between Johnson-Davis Inc., subcontractors, and the Town.

In addition to the work in Pennock Industrial Park, the project also includes infrastructure upgrades along Bush Road, where Johnson-Davis Inc. will be installing a new 15" exfiltration trench to increase drainage capacity in the area. As part of this phase, water utility deflections will also be performed to relocate and protect existing utility lines during construction. These efforts are critical to maintain service to residents while upgrading underground systems.

Construction is expected to be completed over the coming months, with traffic and service disruptions being minimized through coordinated planning.

Project Spotlight: Midway Road

As soon as the contract was awarded, Johnson-Davis, Inc. and Halley Engineering started working with all known utility owners on each of their individual utility work schedules. Johnson-Davis signed a work order with FPUA to provide labor and equipment to facilitate the relocation of all their conflicting water and sewer mains. This made good sense for both parties to enter into the agreement, as we were at each location dewatering for the drainage work and could keep the project moving seamlessly. Jim Amsler, estimator, expertly negotiated with FPUA for pricing the additional work. Alex Guisinger, project manager, has been working with FPUA to keep the utility work scheduled as we progress through the project.

Alex Guisinger worked diligently with SFWMD putting together detailed de-watering plans for permitting so we could start installing well point dewatering system for deep drainage as soon as Halley started clearing and grubbing activities in Phase 1A. Pablo Fernandez, foreman, and his crew started installing the deep and difficult 38" x 60" ERCP trunk line while performing water main offsets for FPUA in July 2024. A total of 1,000' of 38" x 60" ERCP has been installed along with 8 deep J bottom drainage structures and numerous water main offsets. AT&T and FPUA gas worked to ensure that their individual utility relocations stayed on schedule.

With Phase 1A drainage completed, Halley moved into action building the temporary roadway that would allow traffic to be pushed far enough to the north to allow the start of the installation of the concrete box culvert (CBC) in Phase 1 on the south side of Midway Road.

Project Spotlight: Midway Road (con't.)

Pablo and his crew started working on the demolition of the old culvert wing walls and installed drainage items while waiting for Halley to complete the traffic switch to Phase 1.

Mosley and Son's crew got to work on the closure pour to tie us into the old box culvert and we were off to the races setting precast sections of the CBC supplied by Lindsay Precast. The process is multifaceted:

- Set by-pass pumps to convey the canal water around the work area
- Fill in canal
- Set dewatering sock
- Dig out and place bedding stone and fabric and then set CBC sections. Each typical 3-sided section stands 11'-7" x 12'-4" x 6'- 11" and weighs 34,000 lbs. The top sections are set after a long run has been installed and partially backfilled. The sections are set with the help of our friends UESI and their crane.
- Installation of the underdrain is integrated with the backfill for the CBC.
- The installation of the new 12" water main follows closely behind as the backfill operation progresses

The job has just recently passed a small milestone for us. We have crossed Milner Road with the CBC and the water main which means we only have another 300' to get to the MAJOR milestone. The end of the CBC.

From here, we will complete the installation of 15 drainage inlets and 1,650' of trunkline and various pipe crossings. Then we'll remove the old water main and it's up to Halley Engineering to put the pavement down and switch us over to Phase 2.

After the traffic switch is completed, Johnson-Davis crew will return to install FPUA utility offsets and install drainage items that will connect to phase 1 drainage and the system is almost completed. Just a little more drainage in the roadway medium and another successful project will be in the books!

Stay safe, "Construct with Confidence" and it usually turns out well.





Safety Scoop

Lightning Safety Reminder for Outdoor Workers

At Johnson-Davis, we care deeply about the safety of every worker—especially those working outdoors. We want to remind everyone of the hazards associated with working outside, particularly during storm season.

As the Safety Director, I recommend using the **WeatherBug** app for accurate and timely weather updates. Monitoring weather conditions is a key step in preventing lightning-related incidents. Lightning is unpredictable and can strike areas outside of the heaviest rainfall - even up to 10 miles from any visible rain. Many victims of lightning strikes are caught outside because they either failed to seek shelter in time or returned to outdoor activities too soon after the storm passed.

Following are a few safety best practices to consider:

- **Stop tasks early:** If there are signs of an approaching thunderstorm, workers should avoid starting any task that cannot be stopped quickly.
- **Plan ahead:** Proper planning and adherence to safety protocols significantly reduce the risk of lightning-related injuries. Identify safe shelter locations and ensure everyone understands how to get there.
- **Vehicles as safe shelter:** If no safe buildings are accessible, direct workers to hard-topped metal vehicles with the windows rolled up. Remain inside the vehicle for **at least 30 minutes** after the last sound of thunder.
- **Training:** Train all employees on the Emergency Action Plan (EAP), including lightning safety procedures

Following established safety procedures is the best way to protect yourself and others – stay alert, act quickly, and always prioritize safety to ensure everyone goes home unharmed.


